Madam / Sir,

This office has issued several letters/ circulars in the past to regulate the expenditure from Vidyalaya Vikas Nidhi(VVN). All the previous guidelines are hereby replaced vide this letter.

### A) Areas of expenditure

JNVs can utilize VVN for following activities:-

- 1. Day-to-day repair & maintenance of toilets/washrooms, especially leakage & seepage in academic block, dormitories and mess.
- 2. Repair, maintenance and replacement of leaking water taps
- 3. Conducting medical camp for students for health checkup
- 4. Expenditure on treatment of students having serious medical issues.
- 5. Installation & maintenance and repair of CCTV cameras
- 6. Maintenance & repair of incinerators
- 7. Up-gradation of Labs and libraries.
- 8. Procurement of art and music equipments.
- 9. Engagement of coaches/experts (sports/dance/music) for short duration.
- 10. Specialized training on cultural importance like folk/classical dance and music, teaching musical instruments to students etc.
- 11. Assistive devices for CWSN students
- 12. Counseling professional on honorarium basis
- 13. Organizing local excursions
- 14. Conducting yoga camp/promotion of sports activities including honorarium to the experts engaged.

### B) Committee for utilizing the VVN

A committee should be constituted at Vidyalaya level for utilizing the VVN. Following staff of the JNV should be members of the committee:-

Principal
 Chairman of the Committee

• Vice-Principal/Sr. Most Teacher - Member Secretary

• One PGT - Member

• One TGT - Member

• One Creative Teacher - Member

• Office Superintendent/SSA - Member



#### Expenditure norms C)

Principal can spend amount upto Rupees One Lakh for each of the aforementioned activities, in an academic year on the recommendation of the Committee. The expenditure beyond Rupees One Lakh in any of the activity should be approved by the Cluster Incharge Assistant Commissioner.

The proper planning should be made right at the beginning of the academic session for making estimate of the total collection towards the fund and the priority areas where the fund is to be utilized effectively. The purpose of the Vidyalaya Vikas Nidhi is to enhance the quality of activities and facilities provided by the JNV.

#### Monitoring of utilization of VVN at RO level D)

Regional Offices should monitor the collection of VVN and expenditure of VVN in earmarked activities on quarterly basis. At the end of academic session, Regional Offices may submit JNV-wise statement of VVN collection and utilization by second week of April.

This issues with the approval of the Competent Authority.
