Subject: Proposal for extension of services of National Awardee/NVS Incentive Awardee Teachers of JNVs beyond the age of superannuation - reg.

Sir,

I am directed to refer to NVS letter no. 12-22/2005-NVS (E-III) dated 20.9.2018 regarding the subject mentioned above and to say that the matter has been examined. In the context of emphasis being laid on improving learning outcomes and quality of teaching as also on adoption of modern teaching methodologies, e-classrooms etc., the proposal for grant of extension in service to the National Awardee Teachers beyond their retirement is likely to arrest entry of fresh blood into the teaching stream of NVS with attendant consequences.

- 2. In view of the above, the services of distinguished National Awardee Teachers, (who are still willing to offer their services) after their retirement may be availed by NVS by re-engaging them on contractual basis rather than considering automatic extension in service beyond retirement.
- 3. The incentive awardee teachers/staff may perhaps not be equated with the National Awardee Teachers. As such, any proposal for considering extension of their services beyond retirement has not been found worthy of support.
