Due to omission and commission on the part of old time officers on deputation the matter could not reach its logical end as they were drawing old pension from their original departments and were not interested in giving old pension to Navodaya / NVS staff . All favorable Govt , Pay commission circulars concerning giving old pension were suppressed ,hidden . Those were not shown to staff and CPF scheme was forcibly imposed on JNV/ NVS staff without conducting any referendum or seeking agreement / approval of staff .</b>  <b>The Loksabha Pettition committee called Navodaya Vidyalaya Samiti , Ministry of Education , Navodaya Vidyalaya Empleyes Welfare Association ( NVEWA ) ANVSSA , Principals'' Forum and Ministry of finance to submit their respective justifications . Madam, only a small technical glitch has become a stumbling block in the way of realizing the goal of old pension due to which post retirement life of JNVs / NVS staff .


