▪ From 8 PM to 10 PM in hostels taking attendance , counselling, resolving students ' disputes ,listening to complaints and their sorting out , reporting ailing cases to staff nurse and what not .

▪ Remedial classes from 3 pm to 4 pm . No out put .Just an excuse to do head counting . Most of students either drowse sleep or do their homework .

▪ Supervision classes From 6 PM to 7 PM .

■ ■ These duties are in addition to Day School teachers' 8 AM to 1.30 PM duties.

3 . Your good self knows quite well that thousands of students in hostels have committed suicide and fallen prey to accidental deaths . Even today the graph of these untoward incidents are acquiring alarming proportions .

▪ As there is no warden in JNVs. NVS does not allow students to stay in HOSTELS even for one hour ( excluding sleeping time at night ) at a stretch so in the name of academic improvement these all duties are being assigned to subject teachers to ensure students are safe and alive . 24 four hours head counting . This is the psychological fear of NVS management .

▪ Most of unfortunate incidents of gang fights , ragging , stone pelting , indiscipline , vandalism, breaking window panes , setting vehicles ablaze and

many more occur in the wee hours of night a time when all subject teachers are fast asleep after whole day's LASSITUDE . This is regimentation like situation that compelled Einstein to leave school for good . Students in JNVs are being made to run like horses round the clock . They have no time to do homework and sleep and rest . They become irritated and reactive so they get involved in such activities to bust their frustration .

■ This sorry state of affairs in the last 35 years has led to the MASS EXODUS of qualified teachers from NVS . They were chargesheeted , suspended and even terminated for not doing the work ( Hostel management ) they have nothing to do with . NVS muzzled their voice and created an unprecedented cruel , inhuman , undemocratic and unconstitutional system of abuse of autonomy , exploitation , oppression and flagrant violation of human rights . What the subject teachers are faced with is just like the situation of OBJECTIFICATION . At the altar of system they are sacrificing their quality time and falling victims of terminal and incurable diseases .

■ Your good self might be knowing that in the beginning when Samiti started functioning Govt issued circulars to NVS and Ministry for Pension , Warden etc, but where they have gone, only God Knows .

Sir teacher is a human being like you . He is neither super human ,robot nor an image of granite cut in flesh .Please, appoint warden for the sake of safety and security of students . Their life is valuable .

Sir , despite this all we are rendering yeoman's service sincerely and dedicatedly but at the same time feel daunted by the volume of TASK .

This extra burden is bearing heavily on subject teachers .we do not know when it will be borne on NVEWA that APPOINTMENT of WARDEN is our legitimate demand and for the betterment of system .


We request you to bring all your energies to bear upon the task of paving the way for regular appointment of warden and strict compliance of NCPCR and CBSE guidelines.
