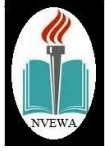

Subject: - Regarding quashing of Librarians duty on Sunday.  
Ref;-F,No 10-1/Weekly off / 2016 –NVs(SA)/377 dated July 12,2024

Respected sir

Good day. Every policy or administrative decision aimed to benefit JNV students requires suggestions and comments from all stake holders, including students, teachers, and parents. The lately released weekly off decision made by NVS authorities is in no way in favor of students, teachers, and Parents.

1 All JNVs in India work on Saturdays when students are in their class rooms. Library is necessary for students during academic hours and at the same time for teacher also . The goal of the School Library will not be served well by closing library on a working day , particularly when students are in the class rooms.

2 JNV's TGT Librarian post is professional in nature. The majority of Librarian's are members of professional societies such as library organizations viz ILA, IASLIC, State Library associations etc.Their seminars, workshops, and conferences are always held on a Sunday. If Librarians are assigned every Sunday duty they will not be able to participate in these events And moreover ,it will harm their professional growth and will have a negative impact on their performance.

3 No school library in our country works on Sundays whereas some libraries like Universities libraries, British Libraries and some Research Libraries are open on Sundays. These work on Sundays with enough qualified professional staffs on a rotation base not regularly requiring the same person to work on all Sundays. Ours is a single man managed Library with no Assistant Librarian , professional Assistants to help the Librarian. Therefore expecting Librarian to open on Sundays is inhuman a kind of forced labour and a pure form of exploitation as well.

4 This change deprives the Librarians of Saturday time slot from the schedule. As a result, he will only have five days to perform his tasks and duties for the entire year. This is an extremely unfair work culture for any system.

5 The idea that the library should remain open on Sundays and be closed on Saturdays is not practical. Students in JNVs can make better use of the library facilities only when NVS adheres to the CBSE Guidelines in this regard . Even the Standard Operating Procedure (SOP) of NEP-2020 stands pyshed aside . The appointment of key personnel for the school library allows it to achieve its goals and provide improved services for its intellectual librarian.

It is not legally valid to permanently fix the duty of Librarians on every Sunday.


