**Subject -- ( A request to modify Winter Break retention schedule of staff ( Lucknow region ) and Summer vacation of Karnataka JNVs ..reg )**

**Respected sir**

Most respectfully, in connection with the above mentioned subject it is humbly brought to your kind notice that NVEWA is in receipt of feedback from Staff mentioned above about changing retention schedule keeping in view of Makar Sakranti festival and inconvenience caused by long distance journey undertaken by staff belonging to remoter and far flung places ( Lucknow region retention schedule commencing from Jan 1 to Jan 14 needs to be changed to Jan 5 to Jan 14 ie 10 days vacation and 10 days retention ) and adverse climatic conditions ( Karnataka, Summer vacation needs to be changed from two months May , June to April , May at par with State of Kerla )

■ Sir , retention is not mandatory as you yourself have made it clear during our meeting and a circular to this effect has already been issued by NVS .Even now Regional offices are shooting up retention circulars with scant regard to staff's social and family obligations which they only can take up during holidays . Sir , this is not fair .

■ Sir , retention is a well thought out trick of Samiti which knows it quite well that staff over burdened with a mountain of non teaching task and unconstitutional round the clock residential set up duties without WARDEN and safety and security staff do not find enough time to complete syllabus and give best result. Samiti is employing vacation retention tactics as a tool to get top result , foolishly set benchmark and practically impossible subject average to show its face in public and to keep Government in dark about exploitation of staff in the name of best result . It amounts to reharnessing an ox after day's hard and rigorous work in the night . Sir , think over it , please.


