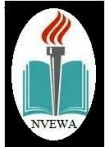

In the first place NVEWA places on record heart felt thankfulness to your goodself for undertaking Innumerable staff welfare measures for the first time ever .</p> <p>In connection with the above mentioned subject We humbly beg to draw your kind attention to the injustice meted out to these two employees .Their grievances are genuine and need to be settled on a priority basis without further delay so that they may take a sigh of relief .</p> <p>1. Smt T Ramadevi 56 on the verge of retirement suffering from many chronical and terminal diseases PA to DC Hydrabad has been unjustly transferred to NLI Rangareddy against a new post created there . In her place a newly promoted male candidate has been given posting . Sir , on perusal of representation submitted by MS T Ramadevi (You are in the know of her case as it stands already represented to RO Hydrabad , NVS and MINISTRY through proper channel but Hitherto unresponded and unsettled) it appears that her transfer is not valid and justified and at the same time it appears to be a case of mental harassment and gender discrimination . Apart from this She is also having problem of quarter allotment, HRA deduction from salary causing her a big financial loss . NVEWA humbly request you to cancel her invalid and unjustified transfer with immediate effect.</p> <p>2. In the second place NVEWA is in receipt of feedback from JNV Kadappa concerning unjust arbitrary attachment of Sh Mallikarjun Librarian to JNV Mandya Karnataka .Office order served to him has no clear reason . What is the matter we do not know but action taken by RO Hydrabad DC is highly objectionable. Under no circumstances It can be justified .Please sir , take cognizance of grievance of Sh Mallikarjun at the earliest convenience.</p> <p>Dear sir , with the exception of RO Hydrabad and Pune the remaining Regional offices and officials are doing good work for Staff Welfare. They feel for pains and sufferings of Staff and try their level best to settle genuine and legitimate Staff grievances. Both the ROs in question are not pro staff. They are keeping on working arbitrarily like a despot with least concern for aspirations and expectations of staff . NVEWA takes strong exception .</p>


