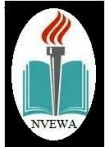

We once again put forward to you the incidences of man handling and criminal offences being meted out recently in JNV Kolasib, Mizoram and JNV Dibrugarh, Assam where the Principal incharge and a 5 months old pregnant staff came under manhandling by a group of draconian students. 2. As per your kind personal commitment 5 months ago, please kindly formulate **\*Hostel Policy\*** without any further delay.


3. Let the processes of appointing permanent warden goes on, but in the mean time, let **\*Warden be appointed\*** in JNVs **\*Through outsourcing\***.
