Subject:- Objections raised by Internal Audit regarding payment of 10% Special Allowance applicable to Teaching Staff of JNVs – Reg.

Sir,

With reference to the subject cited above, it is stated that the Special allowance @ 10% has been approved in respect of Teachers, Librarians and other teaching staff of the NVS by the Ministry of HRD as per the recommendation of the 6<sup>th</sup> CPC as well as in the 7<sup>th</sup> CPC.

The allowance was sanctioned to the teaching staff of JNVs as "Special Allowance". Of late, it is learnt that on the basis of one RTI reply from Hqrs., audit team of RO Lucknow and Chandigarh have raised paras for recovery of 10% special allowance at par with the "Transport Allowance" during vacation/long leave, which is not justified.

Ministry of HRD in its communication dated 03.11.2008 & 04.06.2018, conveyed the approval for payment of 10% special allowance to the teaching staff. Accordingly, Samiti through its notification dated 11.11.2008 and 15.06.2018, communicated the approval for payment of Special Allowance. In the said notifications, there was only approval for Special Allowance and nothing was mentioned/pointed about the recovery of special allowance during vacations/long leave.

Therefore, it is intimated that recovery of special allowance to teaching staff during vacation & leave be stopped with immediate effect, as there are no instruction from Hqrs for non payment of special allowance to the teaching staff during the vacations & leave in the aforesaid notifications.

This issues with the approval of the Competent Authority.
