



2. The expenditure involved on this account will be shared in the ratio of 50:50 between the Central and State Govts/Union Territory Administrations concerned except JK&L, NER States and Sikkim. In case of JK&L, NER States and Sikkim, 100% expenditure will be borne by the Central Govt.

3. The expenditure of the Central Govt share will be debited to Major Head 2076, Minor Head – 113, Sub Head F.2.Expenditure on Trek Expeditions & other Trg activities, Code Head 1/550/02.

4. The revised rate of Honorarium shall take effect from the date of issue of this letter in so far as the Central Govt is concerned. However, in the case of State Govts/UTAs, it shall take effect from the date revised rates are approved by respective State Govts/UTAs.

5. This issues with the concurrence of Ministry of Defence (Fin/GS-II) vide their Dy No. 138/MoD(Fin-GS-II) Dt 19/07/2023.

**REVISION OF MESSING ALLOWANCES FOR ANOs
DURING PRE-COMMISSION/REFRESHER TRAINING**

1. It is to inform that as per request of OTA, Kamptee, a case for revising the rate of Messing Allowance to ANOs during PRCN/Ref Trg Courses from existing Rs 213/- to Rs 450/- (earlier the proposal was for Rs 410/-) has been taken up with MoD and it is in active consideration with MoD.
2. ~~Since the expenditure on this allowance is to be shared in the ratio of 50:50 between Centre and State Govts/UTs, consent is required for getting this allowance at the enhanced rate.~~
3. Also, MoD (Fin) has advised that consent/in principal approval of State Govts/UTs for revising the rate of this allowance from existing ~~Rs 213/- to Rs 450/- is required for processing the case further.~~
4. In view of the above, it is requested to take up the case with your concerned authority of State Govt/UT to obtain their consent/in principal approval for revising the rate of Messing Allowance to ANOs during PRCN/Ref Trg Courses from existing Rs 213/- to Rs 450/-.
